Answer: The Company has been reducing its outgoing costs significantly, dominantly through reduction of costs at Somnio Global, without a reduction in services.

Answer: The Company has a financing facility with Dilato Holdings, its major shareholder with whom it has previously had similar financing arrangements. The Company will continue to review its capital requirements and opportunities to increase those as required.

Answer: Yes it does through the Dilato Holdings funding arrangements.
