## **ASX ANNOUNCEMENT – ORCODA LIMITED (ASX: ODA)**

### **Clarification of SaaS Contracts with Community Transport Providers**

**Orcoda Limited (ASX: ODA)** ('Orcoda' or 'the Company'), the integrated smart transport technology solutions provider, is pleased to announce its wholly owned subsidiary Orcoda Healthcare and Transport Logistics Pty Ltd wishes to clarify a statement made in the 14<sup>th</sup> July ASX announcement re participants in the ACTA trial where one of the participants was missed and the paragraphs should have read as follows:

Orcoda participated in the ACTA Trial with the following Community Transport Providers:

- (i) Astley Care (Western Australia),
- (ii) Derby Home & Community Care (Western Australia),
- (iii) Noarlunga Volunteer Transport Services (South Australia) and
- (iv) TransCare Hunter (New South Wales)

All four (4) were new customers at the start of the trial and all had 3-year contracts commencing on the 1<sup>st</sup> July 2024 as previously announced to the market<sup>1</sup>. The following were existing clients also listed in the 3 April 2024 announcement, Burnie Brae (Queensland) contract commenced on 22 Mar 2023 and was for 3 years plus 1 year option Comlink Australia 3-year contract commenced on 22 July 2023, Transicare (Queensland) renewed their contract for 3 years during the trial on 1 Jan 2025

In the announcement released on 14 July 2025, Orcoda added the following customer to the list released on 3 April 2024, Whittlesea Community Transport (Victoria) who also had had 3-year contract commencing on 1 July 2024. Hinterland Community Services (Central Queensland), Derby Home & Community Care (Western Australia) had 12 month opt outs and only participated for the 12 months of the trial commencing on 1<sup>st</sup> July 2024.

The contracts comprise predominantly of monthly license fees and collectively the contracts represent circa \$1.5 million in revenue over their 3-year initial terms, and the amount collectively is material to Orcoda.

As per the announcement on 14 July 2025, as a result of the trial Orcoda has executed another six (6) new SaaS contracts with Community Transport Providers commencing 1st July 2025 with the following providers:

- (i) St John Ambulance Queensland
- (ii) Catholic Care Central Queensland
- (iii) Kirinari Community Services Albury Victoria
- (iv) Graham House Community Services Murgon Qld
- (v) Capital Regional Community Services Canberra
- (vi) Southport Day links Gold Coast

These SaaS contracts are signed by all parties, are binding and have an initial term of three (3) years commencing 1 July 2025. The Company's revenue for the 3-year initial term of these contracts is circa \$1 million, comprising predominantly monthly license fees.
