CHANGE TO BOARD OF DIRECTORS – APPOINTMENT OF MS SURENA HO AND RESIGNATION OF MR DAVID MCARTHUR

Delorean Corporation Limited (ASX: DEL) (“Delorean” or “the Company”) is pleased to announce the appointment of Ms Surena Ho as a Non-Executive Director, effective 1 August 2025. This appointment follows the retirement of Mr David McArthur from his role as Non-Executive Director, also effective 1 August 2025.

Her expertise spans domestic gas retail, stakeholder engagement, and the development and commercialisation of gas projects in both domestic and international markets.

She has also contributed to industry governance through non-executive roles and currently serves as Strategic Partnership Lead at Fortescue, supporting strategic growth and decarbonisation initiatives.

Ms Ho holds a Bachelor of Commerce (Accounting & Finance) with Distinction from Curtin University of Technology and is a member of Chartered Accountants Australia and New Zealand.

Ms Ho’s combination of deep industry knowledge, financial leadership and strategic insight will further strengthen the Delorean Board as the Company accelerates its national build-own-operate biomethane infrastructure strategy.
