CLOSE OF SHARE PURCHASE PLAN

Canberra, 25 July 2022

Electro Optics Systems Holdings Limited ACN 092 708 364 (ASX: EOS) (EOS or the Company) advises that its Share Purchase Plan (SPP) that was announced on 5 July 2022 closed on Tuesday, 19 July 2022 at 5.00pm

The EOS SPP offer was sent to 18,024 eligible shareholders and valid applications totalling \$202,500 were received from 35 shareholders with an average application value of \$5,786. Directors holding EOS shares, as previously advised, participated in the SPP.

SPP shares are being issued at a price of \$1.20 per share, which is identical to the price paid by institutional and sophisticated investors for shares issued under the institutional placement which raised \$15 million and was completed on 29 June 2022.

The Company expects that the 168,737 new shares issued under the SPP will be issued on Tuesday, 26 July 2022 and dispatched to shareholders on Wednesday, 27 July 2022.

The shares issued under the SPP are expected to commence trading on the ASX on Tuesday, 26 July 2022.

The Board of EOS wishes to thank those shareholders who participated in the SPP.
