APPENDIX 4C AND REPORT ON QUARTERLY ACTIVITIES

Sydney, Australia, 31st December 2021: Victor Group Holdings (ASX:VIG) (“VIG” or “the Company”), releases its cash flow report for the December 2021 quarter (Appendix 4C) and provides an update on the key areas of activity during the quarter ended 31 December 2021.

Principal Activities

VIG and its controlled entities (the “Group”) provides:

- SaaS, IaaS & PaaS services to customers;
- Education cloud platforms which bring together best-in-class resources and applications from strategic partners such as education service and e-learning content providers; and
- A wide range of e-learning solutions for educational institutions, students and parents.

Key areas of activity during the quarter:

- SaaS & PaaS service in PRC – VIG operates its cloud services and software development in PRC through its subsidiary, Shenghan. During the quarter, Shenghan collected \$1.36 million in trade receivables. The sales of existing software inventory are still the main objective for the company to achieve. \$2.54 million cash was paid to purchase new software inventory, which made the company recorded negative operating cash flow. The new inventory purchase is to support the upcoming PPP projects. And the purchase was paid in cash instead of credit accounts due to the larger discount given by the supplier. The cash and cash equivalents position of Shenghan decreased at the end of this quarter due to the new purchase as well. The Group believes the cash flow of the SaaS & PaaS business will turn to positive in the next quarter as the inventory backlog will be less.
- E-learning and cloud education – Shenghan still contributed most of the revenue and cash inflow of the E-learning business during the quarter. The company achieved \$2.08 million cash sale during the quarter and paid \$1.56 million trade payables. The cash flow from E-learning and cloud education increased significantly during the quarter. The new policy and regulation of K12 education provides the company more opportunities to promote its E-learning contents and cloud education platform. The management believes there will be further development in these areas, as the PRC government aims to reduce the burden on students.

- The Company continue to explore acquisition opportunities of businesses in Australian education industry which will have a synergistic effect with VIG's existing e-learning business and have the potential to further strengthen the Company's offerings through better serving overseas and local students and trainees who use VIG's cloud education. One of the key goals of the Company is to increase the e-learning content provided to increase VIG's brand, value, and reputation in the marketplace.

Comment on Appendix 4C Cash Flow Report

The net operating cash flow is negative and decreased in the recent two quarters due to the large amount of new inventory purchases. The group believes that the operating cash flow will turn to positive due to the less cash expenditure on purchases and more contributions from E-learning and cloud education businesses. The Group has also received the financial support commitment from the major shareholders who guarantees the group's debts will be paid as and when they fall due.

Related Party Payments

The December 2021 report includes \$3,200 director's fee paid to the chairman of the Board.
