### **March 2020 Quarterly Report**

UltraCharge Limited ('Company') conducted no operating activities in relation to its existing battery technology assets during the quarter. The Company's activities were focused on the proposed acquisitions of 100% of the issued capital in Watershed Enterprise Solutions Pty Ltd and 100% of the issued capital in Mt Marshall Kaolin.

During the quarter the Company held a General Meeting where shareholders approved:

- A change in the nature and scale of the Company's operations;
- The consolidation of the Company's Shares;
- The issue of Shares to the Watershed Vendors and the issue of Shares to the Mt Marshall Shareholders;
- The issue of proposed incoming Director Performance Rights and Options;
- The grant of Lead Manager Options;
- The issue of Shares under a capital raising; and
- The appointment of the proposed incoming directors.

During the quarter the Company completed a consolidation of its share capital on a 10:1 basis. Following the consolidation there are 112,338,245 Ordinary Shares on issue.
