The loan is repayable on demand and may be drawn down from time to time for working capital purposes. Interest is payable at the base landing rate of a leading Malaysian financial institution of between 4.45% and 6.65% per annum respectively.</p> <p>The founder shareholder has indicated that he will be reducing the line of standby credit, as an application to the High Court, Malaya for the winding-up of the Growers Scheme will entail a non-recovery of the founder shareholder loan.</p> <p>2. A secured loan facility of \$100,000 has been provided by a consortium of lenders organised by 3F Asset Management and is repayable within 6 months from the date of the loan agreement. Interest is payable at the rate of 15% per annum.</p>
