Answer: The company continues to conduct on-site exploration in the mining area and negotiate with the local communities to ensure that the company can quickly start gold mining activities after obtaining EPA permit. During the quarter, the Company continued to focus on the EPA progress of the Kwahu Praso Project and hence the Joint Venture Akeum Adukrom Project was temporarily put on hold. The Company intends to progress with this as soon as possible. In addition, the company will also invite potential partners or investors to inject cash or provide machinery and equipment for the project. Besides that, in current quarter the company has received additional loans from shareholder.

Answer: The company has put significant focus on the EPA progress and pursue negotiations with potential partners or investors may inject cash or provide machinery and equipment for the project.
