#### **NOTICE OF EARLY REDEMPTION OF NOTES**

PMP Finance Pty Limited gives notice that it will exercise its right of early redemption in respect of all its Australian dollar 8.75% fixed interest notes due 23 October 2017 (ISIN: AU3CB0215259) (**Notes**).

The redemption of the Notes will occur on 23 October 2015 (**Redemption Date**). On redemption, Noteholders will receive, for each Note, an amount equal to 103% of the outstanding principal amount of the Note. Noteholders will also receive the interest payable on the Notes for the period ending on the Redemption Date.

In accordance with the terms and conditions of the Notes (**Conditions**):

- 1 the repayment of principal for the redemption of the Notes will be made to each person registered in the register of holders of Notes as the holder of a Note; and
- 2 the final payment of interest on the Notes will be made to each person registered in the register of holders of Notes at close of business on the Record Date (being the eighth day before the Redemption Date) as the holder of a Note.


