**Correction to previously announced Appendix 3B and Appendix 2A documents**

**iSentric Limited** (ASX: ICU) (the **Company, iSentric**) has issued two amended Appendix 3B's this day and annexes to this announcement two correspondingly amended Appendix 2A's to those share issues.

After preparing the Appendix 2A for the issue of placement shares on 13 July 2020 the Company became aware of an error in its disclosure of its earlier lodged Appendix 3B in the Placement Capacity calculation which was a result of an error carried from the Appendix 3B dated 3 March 2020.

The Appendix 3B lodged on 3 March 2020 should have correctly stated that the March 2020 share issue was out of its LR7.1 capacity and instead incorrectly noted that the shares were being issued subject to shareholder approval which was not correct. The result of this error impacted the following Appendix 2A dated 04 March 2020, Appendix 3B dated 08 July 2020 and Appendix 2A dated 13 July 2020 in that the second placement was then made using a combination of the Company's LR7.1 and LR7.1A placement capacity.

These reports have been updated and lodged on this day, accounting for the allocation within the available Placement Capacity categories and amending a minor mistyped number for the number of issued shares on the 8 July 2020 Appendix 3B and 13 July 2020 Appendix 2A. Accordingly the Company confirms that the announcements of 8 July 2020 should have referred to the Successful completion of a Tranche 1 Placement of 25,913,260 shares for a total of \$409,430.

**Compliance with sections 708A(5)(e) and (6) of the Corporations Act 2001 (Cth).**

Accordingly, the Company revises the reference in its cleansing statement lodged 13 July 2020 to be for the slightly lesser number of shares issued. That revised statement should read:

*The Company gives notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) that:*

1. *Under the issue dated 13 July 2020, iSentric has issued 25,913,260 ordinary shares (ICU) at the issue price of \$0.0158 per share without disclosure to investors under Part 6D.2 of the Corporations Act; and*
2. *As at the date of this notice:*
  - (a) *iSentric has complied with the provisions of Chapter 2M of the Act;*
  - (b) *iSentric has complied with section 674 of the Act; and*

*(c) there is no "excluded information" within the meaning of sections 708A(7) and 708A(8) of the Act which is required to be disclosed under section 708A(6)(e) of the Act.*

The Company has notified the ASX of this identified issue and notes there is no breach of placement capacity or of the Listing Rules generally as a result of these corrections however makes them for completeness of disclosure for investors, and is confident that appropriate corrective action was taken immediately upon this discovery.
