1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No, the Company is experiencing an increase in order intake and anticipates ongoing receipts relating to these cold spray machine orders, powder and consumables sales in the US, Australia and Europe. It also continues funded development work with key strategic customers.

In addition, a restructure of the Company's operations was completed in May 2023 resulting in lower cash outflow for ongoing labour and operating costs.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes, the Company successfully completed a capital raise including a share placement and retail entitlement offer in July 2023 raising \$6.0 million in funds, net of raise costs.
