The Company notes that 58,900 YALAL performance share rights were forfeit as a result of employee resignations, not 59,900 2022 YALAL performance share rights. To address this discrepancy, the Company cancels in this announcement only 982,401 YALAL performance share rights, when 983,401 YALAL performance share rights were cancelled on 2 May 2025 for the reasons set out.
