Takeover Offer by Hutchison Telecommunications (Amsterdam) B.V. in relation to Hutchison Telecommunications (Australia) Limited – Notice of Status of Defeating Conditions

Notice of Status of Defeating Conditions

Hutchison Telecommunications (Amsterdam) B.V. (**HTABV**) gives notice in accordance with section 630(3) of the *Corporations Act 2001* (Cth) (**Corporations Act**) in relation to the offers made by HTABV under its off-market takeover bid for all of the ordinary shares it does not already own in Hutchison Telecommunications (Australia) Limited (ACN 003 677 227) (ASX:HTA) (**HTAL**) (collectively the **Offer**) as set out in the Bidder's Statement dated 22 May 2025 (**Bidder's Statement**).

HTABV gives notice under section 630(3) of the Corporations Act that:

- 1 As announced on 23 June 2025, the defeating condition to the Offer in section 10.6(a) of the Bidder's Statement (*minimum 97% relevant interest*) has been satisfied.
- 2 As announced on 24 June 2025, the Offer has been freed from the following defeating conditions:
 - (a) the condition in section 10.6(b) of the Bidder's Statement (*no prescribed occurrences between the date of the Bidder's Statement and the end of the Offer period*); and
 - (b) the condition in section 10.6(c) of the Bidder's Statement (*no dividends between the date of the Bidder's Statement and the end of the Offer period*).
- 3 The Offer is unconditional and has been unconditional since 24 June 2025.
- 4 HTABV's voting power in HTAL as at the date of this notice is 98.61%.
