

## **CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (CTH)**

Horizon Minerals Limited (ASX: HRZ) (the **Company**) hereby advises that the Company has today issued 422,823,368 fully paid ordinary shares at an issue price of \$0.043 per fully paid ordinary share under a two-tranche placement as announced on 26 May 2025.
