Finder Energy Holdings Limited (**'Company'**) requests that the Company's securities be placed in a trading halt with immediate effect, in accordance with ASX Listing Rule 17.1, and the Company provides the following information:

1. The trading halt is to allow the Company to manage its continuous disclosure obligations pending an announcement relating to a capital raising.
2. The Company requests that the trading halt remain in place until the commencement of normal trading on Thursday, 3rd July 2025, unless before that time the Company requests that the trading halt be lifted.
3. The Company expects that the event that will end the trading halt will be release of an announcement referred to in (1) above.
