

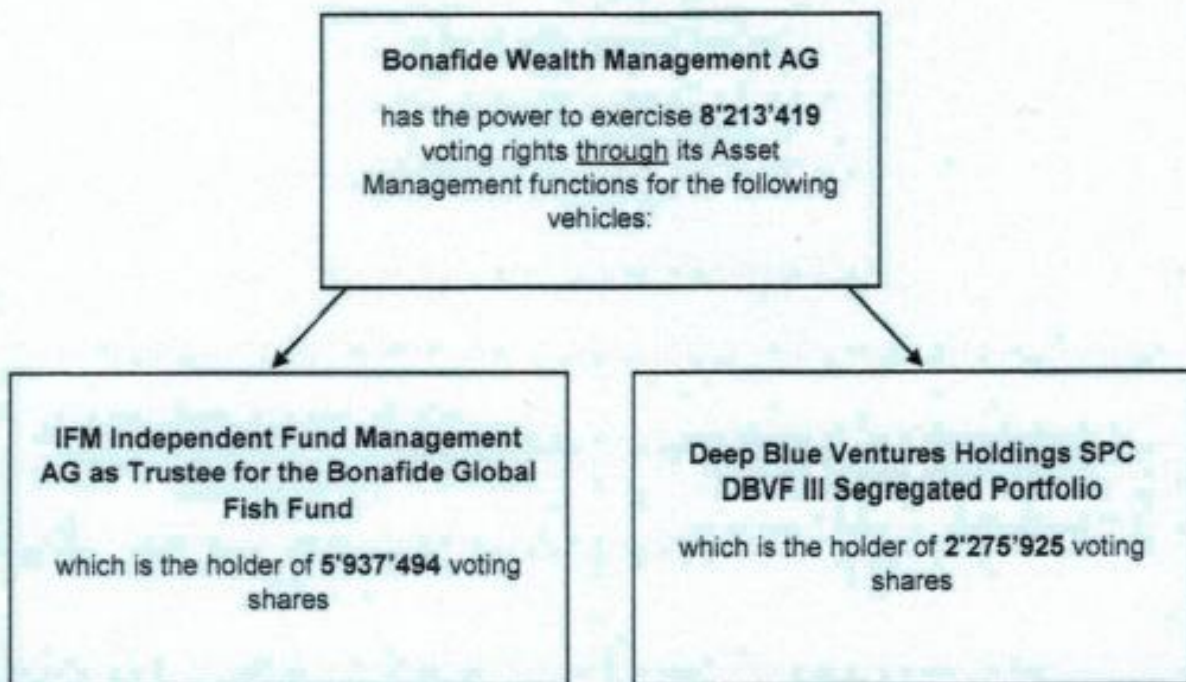





DIRECTIONS
