Signing of first US distributor highlights opportunity for AerisTech

Aeris Environmental Ltd (Aeris or the Company), a smart building automation systems and solutions provider, is pleased to announce the signing of an initial purchase order with its first US distributor.

Agreement

The Company entered into an agreement with H4 Enterprises, a significant US distributor based in North Carolina, for an installation of its AerisTech Syncromesh product for innovative Internet of Things (IoT) building optimisation and management solutions. Under the agreement, Aeris will provide technical support for hardware installation, a software licence, as well as data collection and reporting to the distributor and customer. This initial commercial project also includes use of the Company's core products to treat the air-conditioning systems and generate energy savings for the customer's site. It is anticipated that each of these installations will deliver hardware, software and Software as a Service (SaaS) revenues to AerisTech.

H4 Enterprises will use this initial customer installation to showcase the features, characteristics and capabilities of the AerisTech Syncromesh system, including its energy-saving potential, ease of use, and comprehensive management and control capabilities.

Upon review of energy and cost efficiencies achieved from the project, the distributor plans to use the data to promote this Aeris programme into organisations where it currently holds service contracts.
