Red Sky Energy Limited, ASX: ROG, ("the Company") is pleased to announce the results of the Annual General Meeting of shareholders of Red Sky Energy Limited that was held at the offices of RSM Australia, Level 27, 120 Collins Street, Melbourne 3000 today at 10.00am (AEST).

In relation to Resolution 1 (Remuneration Report), as more than 25% of the vote were cast against this resolution this constitutes a second 'strike' for the purposes of section 250U of the Corporations Act 2001 (Cth) ("the Act"). As a result, Resolution 4 (Spill Resolution) was put to the meeting however was not passed.

While the Company received a second strike on its remuneration report, given Resolution 4 was not passed, the Company is not required to hold a meeting in relation to the composition of the Board.

Resolution 3 (Approval of 10% Placement Facility) was withdrawn from the meeting by the Chairman.

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), details of the resolution and proxies received for the meeting held today are set out in the attached proxy schedule.
