## Conversion of Unlisted Options and Cleansing Notice

Meeka Metals Limited (“**Meeka**” or the “**Company**”) provides this notice under section 708A(5)(e) of the Corporations Act in relation to the issue today of 10,875,000 fully paid ordinary shares in the Company.

The shares have been issued following the conversion of:

- 8,750,000 unlisted options with an exercise price of \$0.04, for proceeds of \$350,000;
