Corporate

As announced on 21 December 2017, following extensive due diligence, the Board elected not to proceed with the proposed acquisition of WindTurbine Pty Ltd (**WindTurbine**). The working capital loan of \$205,000 provided to WindTurbine during the exclusive due diligence process was repaid in full, together with accrued interest of 10% per annum.

The Company's cash balance as at 31 December 2017 was \$289,000.

The Company continues to review new business opportunities and will update investors as and when appropriate.
