Additional Information to ASX Announcement released on 28 May 2020

NetLinkz Limited (ASX: NET) (“Netlinkz” or “the Company”) wishes to provide the following clarifications and additional information in respect of its announcement released on 28 May 2020 where Netlinkz announced that its majority owned subsidiary iLinkAll had partnered with M-Soft and AI Data Innovations to provide a global secure telecommuting product.

Netlinkz announced on 27 February 2020 that iLinkAll had signed a contract with M-Soft to develop and integrate the Virtual Secure Network (**VSN**) product for potential customers. As part of this contract iLinkAll and M-Soft engineers have begun initial configuration and testing of the VSN product with the USB type edge device that AI Data Innovations have exclusive rights to distribute in the USA. The iLinkAll and M-Soft engineers are working to embed the VSN into the AI Data device and produce a prototype and proof of concept. The solution will provide a secure mobile product to bridge the remote working user and the corporate system that monitors and transmits the sensitive data (audio and visual) securely meeting both the high security and privacy requirements.

The announcement dated 28 May 2020 referenced AI Data Innovations operating in 200 markets and having a global workforce of 300,000+. AI Data Innovations conducts business and sales of telecommuting products in 200 markets that include different countries and regions within those countries where there is a demand for their products that is distinct from the national demand. The reference to AI Data Innovation’s workforce represents the total available labour force of direct employees, contractors, outsourced service providers and consultants that form part of AI Data Innovations operational structure and, for clarity, does not mean that AI Data Innovations has 300,000 direct employees.

Revenue from the design and implementation work undertaken by iLinkAll and M-Soft engineers is not material, with no fixed term under the engagement. The Company’s announcement dated 28 May 2020 highlights the opportunity for the Company to target a strong pipeline of possible future subscription revenues from AI Data’s customer base. The Company re-iterates however that the details of such arrangements, including the legal and commercial structure through which any revenues would be generated, are uncertain and are yet to be negotiated.
