Given the status of invoices in Chile as government authorised documents factoring facilities are readily available. This facility is provided by multiple parties in what is essentially a commoditised financing market within the Chilean financial system. All of our customer invoices are covered by these facilities on an ongoing basis for full face value at a cost of approximately 2%. The available amounts were drawn down in full, during the course of January.</p>
