Investment return – May 2025

In the interests of keeping the market informed on a timely basis of the investment returns of the Staudé Capital Global Value Fund ('GVF') portfolio, the manager produces an interim estimate for release to the market ahead of the more detailed monthly investment update and NTA report.

This estimate refers only to changes in the portfolio's value over the month through the manager's investment activities, after the deduction of operating costs and management fees and before any provisions for taxes.

The manager estimates that the investment return for GVF was 2.2% during May.

Including tax payments made during the month, the manager estimates that the pre-tax NTA per share at the end of May was \$1.3380.
