Answer: No, given the challenging retail trading conditions and significant capital requirements for growing the eCommerce segment of the business, the Board has decided to reposition Design Milk to an advertising revenue only model and shut down the eCommerce operations. This significantly saves overhead costs and reduces cash outflows.  8.6.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?  Answer: In order to provide sufficient funding for the business model transition, Design Milk is currently in the process of capital raising by way of a proposed issue of convertible notes, with \$532,800 committed from investors. The issue of convertible notes will be put forward for approval at the upcoming AGM scheduled for 30 November 2022.  8.6.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?
