Answer: The Company is continuing its process to reduce operating cash flows, but it is expected that the current level of cash flows will be maintained for the next two quarters.

Answer: On 24 June 2024 the Company announced a capital raise through a Private Placement (Placement) of up to \$2 million. The Placement would be done in two tranches. The first tranche completed before 30 June 2024 and raised approximately \$460,000. The second tranche will be issued subject to shareholder approval to raise approximately \$1.55 million. The General Meeting to approve the Placement is scheduled for 20 August 2024.

Answer: The Company believes that it will be able to continue its operations and meet business objectives.
