### Distribution Reinvestment Plan - Issue Price June 2018 Quarter

360 Capital Group (ASX: TGP) today announces the Distribution Reinvestment Plan (DRP) issue price for the quarter ended 30 June 2018 is \$0.9921 per stapled security.
