## **HILLCREST'S CURRENT CASE PORTFOLIO**

The Company presently has two funding agreements, being:

### **Computer Accounting & Tax Pty Ltd (In Liquidation)**

HLS has agreed to fund the liquidator of the company in proceedings in the Supreme Court of Western Australia between the company and its directors in relation to the proper entitlement to certain real property and certain monetary amounts.

### **Prunster v Summers**

HLS has agreed to fund the client in a professional negligence claim against a firm of solicitors.

The Company settled one litigation funding case, being:

### **The Bankrupt Estate of Dawson**

In August 2014, the parties in the Dawson case agreed to resolve their dispute without the need for court proceedings. The Company received \$497,145 in October 2014 of which the amount of \$93,153 will represent a profit to the Company.
