Appendix 3G and Appendix 3Y

Fremont, California and Sydney, Australia; 16 March 2020 – Pivotal Systems Corporation (“Pivotal” or the “Company”) (ASX: PVS) attaches an Appendix 3G and an Appendix 3Y in respect of an issue of unquoted options (“Options”) under its 2012 Equity Incentive Plan to Non-Executive Director, Mr Peter McGregor. The issue of Options to Mr McGregor was approved by shareholders at the Company’s Annual General Meeting on 23 May 2019.

While the results of the Company’s Annual General Meeting were communicated immediately to ASX, including the resolution to approve the issue of Options mentioned above, Pivotal recently discovered that the issue of Options, which occurred on 23 May 2019 (PDT) following the Annual General Meeting, had not been disclosed immediately via Appendix 3B to the ASX and the change Peter McGregor’s notifiable interests had not been disclosed within 5 business days via Appendix 3Y, as required at that time, due to an administrative oversight. Given this, the Company is now issuing an Appendix 3G and Appendix 3Y in respect of the issue of the Options to Mr Peter McGregor. The Company confirms that it has reviewed its internal practices and believes that its disclosure arrangements are adequate and are being enforced and that this is an isolated event which does not involve a material breach of the ASX Listing Rules.
