Market commentary

Australian shares fell for the second consecutive month in May with the S&P/ASX 200 Accumulation Index down -2.6%. Most sectors declined with various issues weighing on investor sentiment, including soaring energy costs and extensive commentary around the impact of rapidly rising inflation.

Technology stocks retreated again (down -6.1%) this month and the real estate sector fell (down -6.3%) following Australia's first official cash rate rise in more than a decade and the more recent 0.5% increase at the RBA's June meeting.

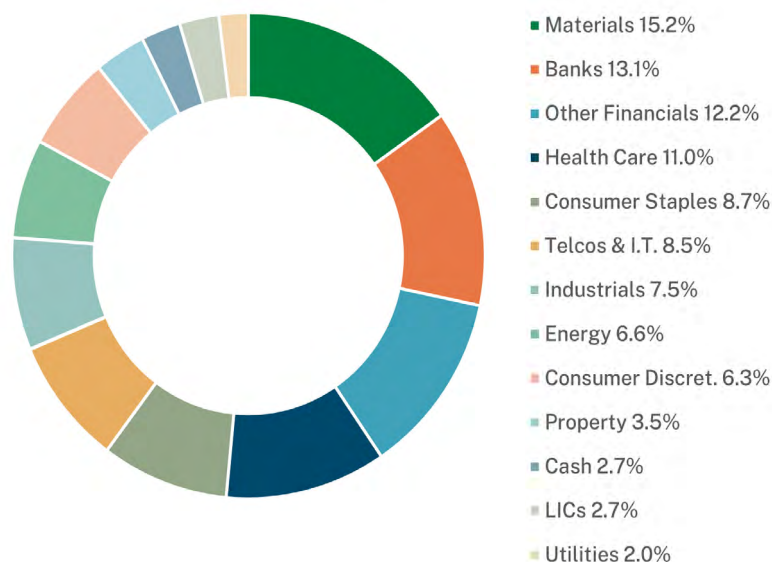
Miners generally bucked the negative trend, helped by easing lockdowns and the prospect of more stimulus in China boosting expectations of increased global demand, particularly for iron ore and energy commodities.

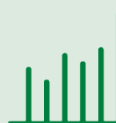
