Interest at 10% is capitalised on the loan for the first 14-months so the first cash payment is not due until Feb 2026 except for 1 instalment amount of \$3M due in June 2025. This secured loan (security over the assets purchased), is expected to mature at the end of September 2027 (unless paid down sooner).
