

(A). On 18 January 2019 the substantial shareholder became the registered holder of 7,280,246 ordinary shares previously held on trust for the substantial shareholder by Muk Min Fa Limited. The transfer of those shares from Muk Min Fa Limited to the substantial shareholder was a transfer from the legal owner of the shares to the beneficial owner of the shares for no consideration.

(B). The change of the holdings of Wenola Pty Ltd and the substantial shareholder, as the controller of Wenola Pty Ltd, transactions between 16 October 2018 – 21 December 2018 amounted to a change of less than 1% of the substantial holder's relevant interest in the shares of CVC Limited. Accordingly, the substantial shareholder was not required to notify the ASX of these changes. These transactions are being disclosed in this notice for complete transparency. Their omission from the substantial shareholder's change in substantial shareholder notice on 17 January 2019 was due to error.

*Wenola Services Pty Limited as trustee for the John Leaver Family Trust ('Trust') holds 50% of the issued shares in Leagou Pty Limited ('Leagou'), and therefore has a 50% economic interest in the shares Leagou

holds in CVC Limited. But for the deemed relevant interest in all of Leagou's CVC Limited shares, if the relevant interest of John Leaver in these shares was equal to the Trust's 50% economic interest in the shares, Mr Leaver would have a relevant interest in 10,352,305 of those shares, and voting power of 33.17% in CVC Limited rather than 41.83%.
