Cleansing Notice under section 1012DAA(2)(f) of the *Corporations Act 2001 (Cth)*

This notice is given by Millinium Capital Managers Limited (**Responsible Entity**) in its capacity as responsible entity for Millinium's Alternatives Fund.

The Responsible Entity today announced a fully underwritten 1:1 non-renounceable pro-rata rights issue of 275,003 fully paid MAX units (**New Units**) held at 7pm (AEDT) on Wednesday 16 December 2015 by all unitholders with registered addresses in Australia (**Eligible Unitholders**) at an issue price of \$6.09 per New Unit (**Entitlement Offer**).

In accordance with section 1012DAA(7) of the *Corporations Act (Cth)* (**Act**):

- a) the New Units issued under the Entitlement Offer will be issued without a Product Disclosure Statement;
- b) this notice is being given under section 1012DAA(2)(f) of the Act;
- c) the Responsibility Entity as responsible entity of the Fund and the issuer of the New Units is subject to regular reporting and disclosure obligations;
- d) as at the date of this notice, the Responsibility Entity as responsible entity of the Fund has complied with:
 - (i) the provisions of Chapter 2M of the Act as those provisions apply to MAX; and
 - (ii) section 674 of the Act as that section applies to MAX;
- e) as at the date of this notice, there is no "excluded information" (as that term is defined in sections 1012DAA(8) and 1012DAA(9) of the Act); and
- f) the potential effect that the Entitlement Offer will have on the control of MAX and the consequences are as follows:
 - a. any Unitholders that do not take up their entitlements in full will have their percentage holding of units diluted (the number of units held by those Unitholders will not change);
 - b. that Logic Fund Management Limited (**Underwriter**) may end up owning 50% of all available units in the Fund following completion of the Entitlement Offer (should none of the Eligible Unitholders take up any New Units under the Entitlement Offer). In that case, the Underwriter may have the ability to significantly influence decisions requiring Unitholder approval, including the ability to pass resolutions to remove and replace the responsible entity. Furthermore, the Underwriter's ownership of 50% of the Units may act as a disincentive for a future large-scale purchase of units in the Fund by an institutional investor. The final interest of the Underwriter will, of course, depend on the amount of New Units that Eligible Unitholders subscribe for under the Entitlement Offer (the greater the number of New Units that Eligible Unitholders subscribe for, the lower the interest of the Underwriter will be).
