Anittel Group Limited (ASX: AYG) are pleased to present the attached **Appendix 4C: Consolidated Statement of Cash Flows** for the September 2014 quarter.

Significant matters include:

- As at 30 September 2014, the **closing cash balance** was **\$1.423M**
- Net operating **cash outflows** in the current quarter were **\$2.054M**, which included **\$1.268 M** of the following abnormal items:
 - \$693k relating to supplier payments from the previous quarter;
 - \$286k of non-recurring amounts regarding divestment of the communications business unit in January 2014.
 - \$145k additional GST payments this quarter due to the timing effect of the GST being paid monthly, not quarterly;
 - \$144k related to product supplier prepayments made in September 2014
- In July 2014 Anittel repaid **\$4M** of debt to Peter & Vicki Kazacos (Kazacos), which will reduce interest expenses going forward.
- At the same time, Kazacos provided the company with a **\$4M debt facility**, which provides Anittel with access to additional funds when and if required.

The company has continued to rationalise its operating costs since divesting its communications business unit to BigAir (ASX: BGL) in January 2014.

Furthermore, Anittel continues to grow its HCS cloud business unit, which to date has resulted in more than 8,000 billable end point services deployed.
