## Research & Development Funds

**Golden Mile Resources Limited** (“Golden Mile”; “the Company”; ASX: “G88”) is pleased to advise that it has received \$379,066.30 from the Australian Taxation Office (ATO) for its 2024 AusIndustry Research and Development Tax Incentive in relation to activities at its 100% owned Quicksilver Nickel-Cobalt Project (“Quicksilver”; “the Project”) located near the town of Lake Grace, approximately 300 kms south-east of Perth, Western Australia.

The Research and Development claim was specifically for the ‘Development of Novel Laterite Nickel/Cobalt Process Technology’ at Quicksilver, where drilling by the Company in 2017-2018 resulted in a maiden indicated and inferred Mineral Resource Estimate of 26.3Mt at 0.64% Nickel and 0.04% Cobalt for 168,500 tonnes of contained nickel, and 11,300 tonnes of contained cobalt<sup>1</sup>.

Golden Mile’s Managing Director, Mr Damon Dormer, welcomed the tax incentive refund which would provide additional funding for Company’s exploration programmes at the Pearl Copper Project in Arizona, USA.

“Golden Mile’s current focus is on the Pearl Copper Project in Arizona where we recently wrapped up our maiden drilling program.

A total of ten RC holes were drilled for a total of 1,186.3m and we now look forward to receiving assay results, in the coming weeks. Work has commenced on planning for follow-up exploration programs including geophysical surveys and drilling.”
