Sales Pipeline Update

As of month end, the Group had US\$71.86 million in attorney review or under contract, US\$31.62 million of additional inventory listed on the market for sale, as well as US\$47.02 million in the sales pipeline.

Sales Pipeline Update, cont.

Assets marked as being in attorney review or under contract are likely (but not guaranteed) to close in coming months. The sales pipeline includes properties that will be listed for sale imminently, as well as properties where a tenant has submitted a notice to vacate at the future lease expiration date but has not yet vacated. These vacancy notices are typically submitted 1-2 months before lease expiration. Subject to market conditions, the Group intends to list these properties for sale once they become vacant.

Capital Management Update

Following the commencement of the Group's buyback program in July 2022, as at 31 March 2025 the Group has executed on the purchase of 105.90 million URF Stapled Securities (previously referred to as URF Ordinary Units) for total consideration of \$30.97 million. As at 31 March 2025 the Fund had 690,882,004 URF Stapled Securities on issue.

Subsequent to month-end, the Group announced a distribution of 1 cent per stapled security, with the payment expected to be on or around 1 May 2025. This announcement can be found [here](#).
