Cleansing notice under section 708A of the Corporations Act

Omega Oil and Gas Limited (ASX: OMA) (“**Omega**” or the “**Company**”) announces that the Company has today issued and allotted 150,000 fully paid ordinary shares in the Company, from exercise of options, as announced in the Appendix 2A dated 19 February 2025 (**Shares**).
