ALTAMIN LIMITED (ASX: AZI) – RETAIL ENTITLEMENT OFFER NOW OPEN

On Thursday, 31 October 2024, Altamin Limited (ABN 63 078 510 988) (the **Company** or **Altamin**) announced that it was conducting a four (4) for five (5) pro-rata accelerated non-renounceable entitlement offer (**Entitlement Offer**) to raise up to approximately \$8.4 million (before costs) via the issue of new fully paid ordinary shares in the Company (**New Shares**) at a price of \$0.024 per New Share (**Offer Price**).

The Entitlement Offer comprises an institutional entitlement offer (**Institutional Entitlement Offer**) and an offer to eligible retail shareholders (as defined below) (**Retail Entitlement Offer**) at the same Offer Price and ratio. The Institutional Entitlement Offer has closed and the results were announced to the Australian Securities Exchange (**ASX**) on Friday, 1 November 2024.

The funds raised from the Entitlement Offer will predominantly be applied towards conducting a sale process of the Gorno Project (refer to the Company's ASX announcement dated 31 October 2024 for further details) and exploration activities at Altamin's Lazio Project, with discrete spending at the Punta Corna cobalt, Corchia copper and Villar graphite projects, towards general corporate and administration expenses, and working capital. The use of proceeds from the Entitlement Offer may be varied as the Company progresses the sale of the Gorno Project or advances towards Final Investment Decision (including, in either event, seeking to obtain a mining licence at the Gorno Project). The Company's Board reserves the right to alter the way in which funds are applied. Please refer to Altamin's announcement and investor presentation lodged with the ASX on Thursday, 31 October 2024 for further details.

Entitlement Offer

The purpose of this letter is to inform you about the Entitlement Offer and to explain that if you are an Eligible Retail Shareholder (defined below), you will be able to subscribe for four (4) New Shares for every five (5) existing Altamin fully paid ordinary shares (**Shares**) held by you at 7:00pm (AEST) on Monday, 4 November 2024 (**Record Date**).

New Shares issued under the Entitlement Offer will be fully paid and rank equally with existing Shares from the date of issue.

The Entitlement Offer is not underwritten.

The Entitlement Offer is being made by the Company without a prospectus or other disclosure document in accordance with section 708AA of the *Corporations Act 2001* (Cth) (the **Corporations Act**) (as modified by ASIC Corporations (Non-Traditional Rights Issues) Instrument 2016/84 and ASIC Corporations (Disregarding Technical Relief) Instrument 2016/73) (together, the **ASIC Instruments**).

The expected date of issue of New Shares under the Retail Entitlement Offer is Thursday, 21 November 2024. **Shareholders should keep in mind that on Wednesday, 20 November 2024, the proxy cut-off time for the Annual General Meeting is 1:00pm (AEST) and the register cut-off time for Annual General Meeting is 7:00pm (AEST).** The Annual General Meeting is scheduled to be held at 1:00pm (AEST) on Friday, 22 November 2024.



Eligible Retail Shareholders

Eligible Retail Shareholders are those persons who:

- 1 are registered as a holder of one or more existing Share(s) as at the Record Date;
- 2 as at the Record Date, have a registered address on the Altamin share register in Australia, Belgium (institutional investors only), China (institutional investors only), Germany, Hong Kong, Italy, Japan, Mauritania, New Zealand, the Philippines, Singapore, Slovakia, Switzerland or the United Kingdom and who are not in the United States and are not acting for the account or benefit of a person in the United States or are a person that Altamin has determined in its discretion is an Eligible Retail Shareholder;
- 3 are not in the United States and are not acting for the account or benefit of a person in the United States (to the extent that such shareholders hold Shares for the account or benefit of such person in the United States);
- 4 did not receive an offer to participate (other than as nominee) in the Institutional Entitlement Offer; and
- 5 are eligible under all applicable securities laws to receive an offer under the Retail Entitlement Offer without a prospectus or other disclosure document or any lodgement, filing, registration or qualification.

Shareholders who are not Eligible Retail Shareholders are ineligible retail shareholders and are consequently unable to participate in the Retail Entitlement Offer.

Retail Offer Booklet

This letter is not an offer document but is a notice of some key terms and conditions of the Retail Entitlement Offer. Full details of the Retail Entitlement Offer are set out in the Retail Entitlement Offer Booklet (**Retail Offer Booklet**). Terms capitalised but otherwise not defined in this letter have the meaning given in the Retail Offer Booklet.

Eligible Retail Shareholders can access a copy of the Retail Offer Booklet online via <https://investor.automic.com.au>, together with their personalised Entitlement and Acceptance Form which contains details of their entitlements under the Retail Entitlement Offer.

You should read the Retail Offer Booklet carefully and in its entirety before deciding whether to participate in the Retail Entitlement Offer.

Actions which may be taken by Eligible Retail Shareholders

If you are an Eligible Retail Shareholder, you may take any one of the following actions:

- 1 take up all of your entitlement and apply for additional New Shares over your entitlement under the top-up facility (subject to scale back in accordance with the policy detailed in the Retail Offer Booklet);
- 2 take up all of your entitlement and not apply for any additional New Shares under the top-up facility;
- 3 take up part of your entitlement and allow the balance to lapse, in which case you will receive no value for those lapsed entitlements; or
- 4 do nothing, in which case your entitlement will lapse and you will receive no value for those lapsed entitlements.

Your entitlements under the Retail Entitlement Offer may have value and it is important you determine whether to take up (in whole or in part) or do nothing in respect of your entitlement. There are a number of matters that you should consider in relation to taking up your entitlement. You should ensure that you understand the tax consequences of any action that you take, and you should consider seeking advice from your professional adviser.

The Entitlement Offer is non-renounceable and therefore your entitlement will not be tradeable on the ASX or any other exchange, cannot be sold and is not otherwise transferable. This means that you will not receive any value for entitlements you do not take up and your percentage shareholding in the Company will be reduced.

Taking up an entitlement

If you wish to take up all, or part of, your entitlements under the Retail Entitlement Offer, please pay your application monies by following the instructions set out on the personalised Entitlement and Acceptance Form. If you are unable to pay by BPAY® (because you are an overseas based shareholder without an Australian bank account) or are having difficulty paying by BPAY® you are able to pay via EFT as per the instructions on the form.

Application Monies must be received before **5:00pm (AEST) on Monday, 18 November 2024** (unless the Retail Entitlement Offer is extended).

Nominees must not take up entitlements under the Retail Entitlement Offer on behalf of, or send any documents related to the Retail Entitlement Offer to, any person in the United States.
