

## Cleansing Notice

**Rincon Resources Limited (Rincon or the Company)** (ASX: RCR) advises that it has issued and allotted

- 94,846,559 fully paid ordinary shares at \$0.025 per share for cash considerations; and
- 1,250,000 fully paid ordinary shares have been issued for the acquisition of an exploration tenement.

Secondary Trading Exemption:

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By the Company giving this notice, a sale of the Shares noted above will fall within the exemption in section 708A(5) of the Act.

  - (ii) that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
    - 1) The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
    - 2) The rights and liabilities attaching to the Shares.
