## June 2020 Quarter Activity Report and Appendix 4C

PLC Financial Solutions Limited (ASX: PLC) (**PLC or the Company**) provides the following quarterly activity report and Appendix 4C.

### Quarterly Activity Report – 1 April to 30 June 2020

At the beginning of the quarter the Company was in advanced discussions with a business to complete a backdoor listing. Unfortunately, the target company could not satisfy the compliance and due diligence process established by the Board to achieve the regulatory approvals to proceed, therefore the Company did not move forward with this transaction. Details of the business are not allowed to be released due to executed confidentially deeds.

The PLC Board are currently working through various strategies and avenues for capital raising but the impact of the COVID-19 pandemic has resulted in a slow-down in economic activity across most industries, which has been material, and we are yet to be successful to complete any capital raising as at the date of reporting.

The Company looks to further reduce costs and assess the impact over the next quarter and continues to seek opportunities to complete a backdoor listing. The Board are currently reviewing a number of projects that have been presented but at this stage the review process is in the early stages and the Board will advise if and when we are ready to proceed to the next stage.

Cash on hand at the end of the quarter was \$1k compared to \$10k at the end of the prior quarter.

### Listing Rule 4.7C.1

Whilst there were no substantive business activities during the June 2020 quarter, the Board continued to seek business projects for a reverse takeover and in that regard compliance and due diligence costs totalling \$9,000 was incurred exploring various potential business opportunities.

Administrative and corporate costs were not incurred during the June 2020 quarter, the directors did not take any fees and several of the support service providers agreed to “push out” payment pending a capital raising.
