### **Resignation of Non-Executive Director**

Elanor Investors Group ("ENN" or "Group") advises that Mr. Kin Song Lim has resigned as a Non-Executive Director of Elanor Investors Group (ASX: ENN), Elanor Retail Property Fund (ASX: ERF) and Elanor Commercial Property Fund (ASX: ECF), effective 25 January 2021.

Mr. Lim has served the Boards of ENN, ERF and ECF since May 2019 as the representative of Rockworth Capital Partners (Rockworth). Mr. Lim's resignation from the ENN Board follows his resignation from the Rockworth business. Rockworth is the holder of approximately 15% of ENN and under the terms of its Strategic Alliance Agreement with ENN, will nominate a replacement representative for appointment to the Board in due course.

The Board would like to express its gratitude to Mr. Lim for the contribution he has made to the Group throughout his tenure.
