## Janus Electric Holdings Limited – (ASX: JNS) – Formerly ReNu Energy Limited – Anticipated Reinstatement to Quotation

### Description

It is anticipated that the securities of Janus Electric Holdings Limited ('JNS') will be reinstated to quotation at 10:04:30am (+/- 15 seconds) AEST on Wednesday, 21 May 2025, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

JNS raised \$8,764,935.60 pursuant to the offer under its Prospectus dated 25 February 2025 ('Prospectus') and as varied by first supplementary prospectus dated 25 March 2025, the second supplementary prospectus dated 3 April 2025, the third supplementary prospectus dated 10 April 2025 and the fourth supplementary prospectus dated 17 April 2025, by the issue of 43,824,678 ordinary fully paid shares at an issue price of \$0.20 per share.
