



Quarterly Activity Report - Q2 FY25

Wrkr Ltd (ASX: WRK, Wrkr or Company) is pleased to announce its Quarterly Activity Report and Appendix 4C (Quarterly Cash Flow report) for the quarter ending 31 December 2024.

Overview

From October to December 2024, Wrkr focused heavily on commercial negotiations, formal technical responses, and security assessments across multiple super funds and HRM providers. Given this commercial progress and the aggressive timetable for Payday Super, the Wrkr Board approved the acceleration of investment. The management team has begun hiring additional delivery staff and is proceeding with implementation planning ahead of finalising commercials.

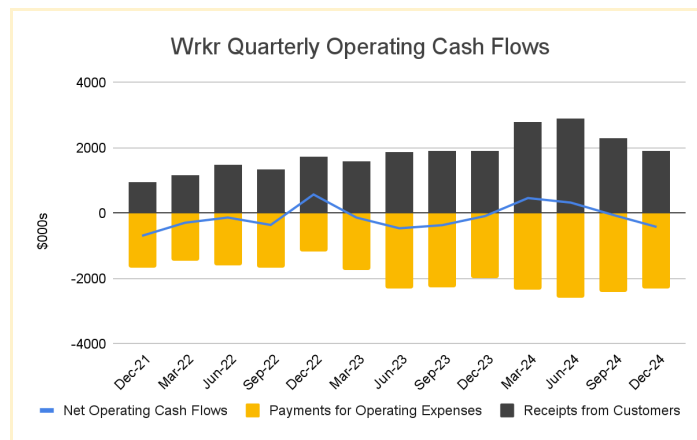
With the MUFG partnership industry build nearing completion and market testing (through the Rest pilot), it is expected that Q3 and Q4 will focus on three areas:

- Concluding pilot milestones and beginning implementation for Rest and other Funds currently using the MUFG Retirement Services internal superannuation clearing house;
- API development to support the detailed requirements for HRM platform providers;
- Building accelerators to expedite the onboarding of Funds ahead of Payday Super.

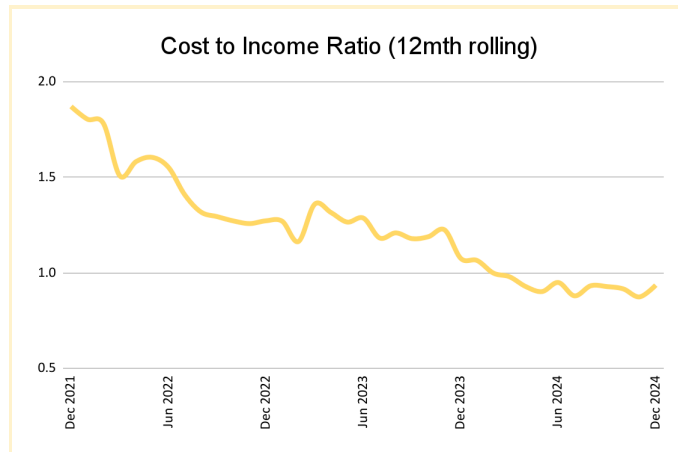
Our financial focus on cost management continues to balance investment and revenue while supporting longer-term growth. Growth in our FY25 revenue, when compared to FY24, primarily depends on implementation fees from the Super Funds. Wrkr has adequate capital to deliver on the current growth objectives and licence and transaction fees will be generated post-implementation.



Q2 FY25 FINANCIAL HIGHLIGHTS



- Significant investment was made in the quarter for the MUFG Retirement Solutions industry and Hong Kong solutions. Major contracted milestones were reached throughout the quarter with cash receipts linked to these milestones due in Q3.
- Although net operating cash flows and cash receipts declined in Q2 compared to Q1, this does not reflect the progression the team made on strengthening pipeline opportunities and significant development of the platform in readiness for PayDay Super.
- To ensure readiness to execute the strengthening sales pipeline and post-delivery support functions, Wrkr has invested in its team with key hires including the appointment of:
 - Chief Operating Officer and Head of Delivery;
 - Senior Cyber Security Analyst; and
 - 3 x Cloud Engineers
- With a cash balance of \$7.2m at 31 December 2024, Wrkr is well positioned to scale up as required as it executes on its sales pipeline.
- Wrkr continues to focus on investing for growth and carefully managing costs. This is reflected in the **improvement in the cost-to-income ratio by 17% over the last 12 months**.

Business Strengths

Wrkr remained focused in Q2 on delivering its client-driven and strategic programs:

- Wrkr PLATFORM enhancements
 - API first channel refresh - support new and existing Digital Service Partner ecosystem customers broaden their propositions and scale, including preparation for Payday Super.
 - Wrkr PLATFORM Payday Super ready (Continue Scale and load testing).
- MUFG Retirement Solutions - international deployment
 - The Hong Kong build testing is near completion and will go live in Q3. MUFG has requested additional features and are in the development pipeline for Q3 and Q4.
- MUFG Retirement Solutions - industry build for Payday Super
 - Rest pilot ready with development continuing on additional features in preparation for the rollout of the solution post-completion of the pilot.
- ART Beam platforms - ongoing platform performance and enhancements in readiness for Payday Super.
- Wrkr integrations to third-party Payrolls and HCM is progressing on schedule with early engagement of several new delivery partners for Workday and SAP business users.
- Successful completion of the ISO27001 and GNGB audits, showing the continued investment in our security posture.

Wrkr continues to see full retention of key platform customers and high retention of our Super, Pay processing, STP and SMSF customers.



Other

The cash expenditure incurred on the operating activities of the business in the quarter are summarised as follows:

- \$1,636k Staff costs
- \$342k Administration and corporate costs
- \$302k Operating costs
- \$8k Finance Costs
- \$27k Advertising and marketing

As required to be disclosed under ASX Listing Rules, payments to related parties in the current quarter amounted to \$58k. This amount is shown in Appendix 4C under Section 6. Payments to related parties of the entity and their associates relate to directors' fees.

Wrkr provides compliance and payment software solutions to create efficiencies for Superfunds, payroll service providers and both large and small Australian employers.

The company has three core offerings:

- **Wrkr PLATFORM**, a modern cloud-based compliance platform for handling messaging with ATO (SuperStream, STP 2.0, PEPPOL, SBR and State authorities) and orchestrating payment processing for worker pay and super contributions for Fund Administrators
- **Wrkr PAY**, a superannuation gateway and clearinghouse and payment handling solution for processing of employee pay and super contributions for Payrolls and Superfunds. This product includes Wrkr SMSF Hub providing ATO messaging and contributions compliance for SMSFs
- **Wrkr READY**, a white-label employee onboarding solution to manage the compliant onboarding of full-time and casual workers
