



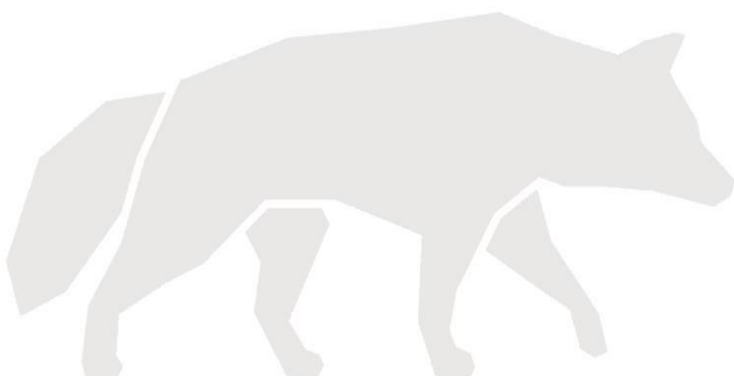

## Chairman's Message

Dear Fellow Shareholders,

As Chair, and on behalf of the Board of Directors, it is my pleasure to present the 2022 Annual Report for Scout Security Limited, a company that is building a strong position and reputation as a global security platform technology provider.

It is often the case, when developing and commercialising emerging technology, that things seem to take longer than expected or planned. That has been the case for Scout since the Company made its strategic pivot towards white-labelling. Scout made that decision in recognition that its best-in-market home security applications and hardware required too much capital to be able to efficiently gain scale through direct customer acquisition, rendering Scout's previous path unlikely to build a valuable business.

However, the 2022 financial year was the year that things finally started happening for Scout. Our first US telecommunications partner launched its Scout-powered security offering in September 2021, achieving initial results that have exceeded our expectations. Annualised Recurring Revenue (ARR) grew to \$1.05m at FY22 end from \$0.52m at FY21 end, with that initial partner delivering over 1,000 new customers per month once sales ramped up.

During the year, Scout's strategic shareholder Prosegur commenced marketing its first Scout-powered offering into the Peruvian market following a launch in late FY21. Gaining scale through this channel has been a slower burn, but we continue to work with Prosegur to optimise its offering in this first market and prepare to launch together into new markets.

As we came towards the close of the financial year, we were also excited internally with progress being made towards a partnership with a second, larger US telecommunications company, US\$9 billion market cap Lumen Technologies Inc (NYSE: LUMN). An agreement Scout signed with Lumen and announced in August 2022 is cause for great optimism.

The Lumen partnership heralds a technology shift for our business. Typically, Scout-powered services have required subscribers to purchase a "hub" device to centrally manage the security set-up. However, new technology in WiFi routers now being deployed by Lumen and other players allows consumers to turn on Scout-powered monitoring and connect various security devices without the initial capital outlay. This exciting development removes a potential roadblock to purchase and will support our plans to gain scale in FY23.

It has become fashionable lately for businesses to talk about pathways to positive cash flow. Scout has always been very focused on achieving strong cash flow generation. Although we are not there yet, hardware orders Scout has received to date from its first US telecommunications partner alone would, if and when all sales convert to subscriptions, generate enough recurring revenue to cover Scout's operating expenses. Scout only needs one large active customer for the business to generate positive operating cash flow, and each additional white label partner will compound and accelerate this trajectory.

Scout's Board of Directors are all very much aligned with you, the shareholders of this company, and have sought to manage the company's capital efficiently. During the 2022 financial year, members of the Board and management invested personally in a placement of Scout shares priced at a significant premium to the market price. This group also provided debt funding in order to extend the company's runway. This personal backing reflects the strong faith that Scout's Board and management maintain in the Company's strategy and prospects.

With the arrival of the Lumen opportunity and an encouraging pipeline, it is now time for Scout to lock in its funding and get moving to deliver growth in FY23 and beyond. We have asked shareholders in September 2022 to support an entitlement offer as part of a \$2.3 million capital raising. While the entitlement offer is largely underpinned by commitments from key shareholders, we encourage all shareholders to consider increasing their support of the Company by taking up their entitlements under the offer.

Throughout the last financial year, Scout's management and employees have gone to great lengths to execute on opportunities in what has been a challenging operating environment for technology companies. I am proud of how our team has addressed its challenges and I would like to thank our personnel for their ongoing dedication.

I would also like to thank my fellow Board members and shareholders for their commitment and support. As our footprint expands, and our platform continues to develop, we look forward to having you share this journey with us in FY23.

### 5. Operating and financial review

#### 5.1. Nature of Operations Principal Activities

Scout Security Limited (ASX: SCT or the Company) is a Security-as-a-Service company. developer of a technology platform that powers smart home security offerings from leading Security, Telecommunications and PropTech companies. With its DIY range of security devices and seamless integration with other best-in-class smart home solutions from the likes of Amazon Alexa, Google Assistant and Yale, Security.org's 2021 review says Scout's offering "redefines DIY home security". Scout's platform facilitates professional security monitoring, while its mobile app is a powerful command system for end users to monitor their home and manage their security remotely. Scout's strategic shareholders include global security company Prosegur and the Amazon Alexa Fund. Scout-powered solutions are currently being rolled out by Prosegur and top tier Internet Service Providers around the world.

### 5.2. Operations Review

#### BUSINESS DEVELOPMENT

The Company's focused on both expansion and growth in FY22 through new and existing white label partners. Key business development announcements during the period included:

July 2021:	Receipt and announcement of first hardware shipment to telco partner on July 7, 2021
July 2021:	Scout joins the Competitive Carriers Association (CCA), the leading organization for wireless providers
September 2021:	Telco partner Windstream <sup>1</sup> launches Kinetic Secure Home, a white label home security solution powered by Scout
December 2021:	Scout signed a partnership agreement with Hyperion <sup>2</sup> , a master agent for T-Mobile and other US carriers
February 2022:	Letter of Intent signed with key hardware supplier to reduce cost and minimum order quantities, enabling the Scout sales team to sell into smaller channel partners at lower volume
March 2022:	Annualised recurring revenue (ARR) through telco partner exceed A\$200k
May 2022:	Annualised recurring monthly revenue streams from Windstream, Prosegur, Stanely Black and Decker, Zego, and Scout direct-t-consumer totaling more than \$A1.1 million

This financial year Scout launched its latest white label partner Windstream, a mid-sized us internet service provider with more than 1.3 million existing subscribers. Further the company continued growing its partnership with Prosegur to sell the Qido brand within Peru, and also has built a robust pipeline of future white label partners.

#### Windstream partnership

Launching in September 2021, Kinetic Secure Home (KSH) by Windstream marks the first major US telco to white label the Scout Security-as-a-Service platform. The Company built the solution throughout FY21, with the majority of hardware ordered and delivered in the same. In FY22 KSH launched with two tiers of service to Windstream customers: 1, a camera only solution providing a lower cost entry point to home security while still allowing remote monitoring through the Scout built applications. 2, a fully DiY home security solution with professional 24/7 monitoring. Sales growth was strong through the year with gross sales exceeding 1,000 new customers monthly, and average revenue per user (ARPU) of approximately A\$8 significantly exceeding original estimates of A\$4.70.

Through close collaboration, Scout and Windstream have continued to evolve the program. Engaging in joint marketing initiatives, ongoing training of their retail and inside sales staffs, and releasing regular feature updates to users. This high level of engagement has delivered strong results leading to total annualized recurring revenue from all sources to exceed A\$1.3 million before the end of the fiscal year.

**Business Growth**

As Scout's existing partnerships with Stanley Black and Decker and Prosegur continued to generate profitable monthly recurring revenue (MRR), the Company launched Kinetic Secure Home with Windstream, and continued to pursue a robust pipeline of new partners. Windstream continues to over deliver in regard to ARPU, while adding to annualised recurring revenue (ARR) on a monthly basis. Through these partnerships, and Scout's direct-to-consumer business, the Company has increased MRR every month in the fiscal year.

Prosegur continues to sell into the Peru market to establish the Qido brand. Plans for an additional Latin American country, though expected during the fiscal year, were delayed until FY23 in order to first grow the Peru marketing while establishing best operational practices.

The Company entered into referral partner and master service agreements with Hyperion Partners, a master agent for T-Mobile and other carriers in the US. Progress is being made to finalize the financial terms in the statement of work to where Hyperion will both refer Scout products and services to their customers as well as directly resell them.

**Industry Engagement and Recognition**

It was a great year of recognition for Scout within the industry. Along with receiving several accolades from leading associations and publications, the Company also joined the CCA to further develop and amplify its voice within the US cellular carrier and broadband sectors. Scout also received several positive reviews of its products from tier 1 technology press such as PCMag and Tom's Guide.

During the year, Scout joined the Competitive Carriers Association (CCA), America's leading organization for wireless providers and associated parties. This allows Scout to build meaningful relationships with a large group of cellular carriers leading to an enhanced pipeline of white label partners.

The Company won the "Best-In-Class Partnership Award" from the Broadband Multimedia Marketing Association (BMMA) for innovation and excellence due to its white label partnership with Windstream.

Forbes recognized Scout as one of the "Best Home Security Companies of 2022".

**5.3 Corporate****Appointments**

Early into the fiscal year, Martin Pretty was appointed chairman of the board, assuming the position August 23, 2021. Mr Pretty has served as a non-executive director since July 2020 and is also managing director of the boutique fund manager, Equitable Investors, and a non-executive director of financial services group Centrepont Alliance Ltd (ASX: CAF) and technology communications company Spacetalk Ltd (ASX: SPA).

In December 2021, Scout announced that executive director and co-founder Dan Roberts would step out of the CEO role and into the position of executive director and Chief Product Officer. His focus is now on strategy, product roadmap and design.

Ryan M. McCall assumed the role of CEO on January 3, 2022. Mr. McCall comes to the company with as an experienced business and people leader with 14 years of global cross functional experience in consumer technology and in growing teams, revenue, and profitability.

During the 4<sup>th</sup> quarter of the fiscal year, the Company continued to improve its operations by appointing Kevin Brennan as COO, Hilari Smith as VP of Accounting, and Kim Clark as Company Secretary (effective July 4, 2022).

**Directors' report****Funding activities**

During the year the Company executed on several smaller facilities to build working capital for continued growth of the business. Participants for these raises included the Board of Directors, CEO, and sophisticated investors. These facilities include:

Capital raise and restructuring totaling A\$650k completed in December 2021, comprising a placement to Scout directors and sophisticated investors and the extension of 94% of existing convertible notes to December 2023.

In May 2022, the Company closed on AU\$350k of working capital via receivables financing, participants including CEO Ryan McCall and Executive Director Dan Roberts.

In April 2022, the Company secured a working capital facility of US\$400k, which included issuing the lender 5,400,000 options at a strike price of AU\$0.10.

Scout is currently exploring new funding avenues that would provide enough operational cash flow to support upcoming white label partners, as well as a bridge to the Company's monthly recurring revenue outpacing cash burn.

**5.4. Outlook**

FY22 was a year of organizational growth and change for Scout. Through the fiscal year the Company appointed a new CEO, Chairman, COO, Chief Product Officer, Company Secretary and VP of Accounting. These moves were made for many reasons, but first and foremost was to improve the operational efficiency and competency of the business. Every move has thus far achieved this core goal, allowing Scout to operate more nimbly with improved governance, fostering an environment focused on growth.

The Windstream launch marks a significant milestone, one in which Scout has cemented itself as the premier white label Security-as-a-Service company. That combined with the Company's own direct-to-consumer sales, other existing partners, and expected future partners, leads us to expect we will achieve our goals of recurring monthly revenue balancing cash burn by itself within the near term. Windstream alone would accomplish this goal once it has sold through its initial order of hardware, and the addition of new partners in fiscal year 2023 will only expedite meeting our financial goals.

**5.5. Financial Review**

The financial statements have been prepared on a going concern basis, which contemplates the continuity of normal business activity and the realisation of assets and the settlement of liabilities in the ordinary course of business. The Group incurred a loss for the year of \$3,288,924 (2021: \$3,943,796 loss).

The Group's revenue for the year ended 30 June 2022 was recorded at \$4,310,127 as compared with the previous year ended 30 June 2021 which recorded \$1,671,133.

The net assets of the Group have decreased from 30 June 2021 by \$2,377,910 to \$(2,437,809) at 30 June 2022 (2021: \$(59,999) net liabilities).

As at 30 June 2022, the Group's cash and cash equivalents decreased from 30 June 2021 by \$1,665,712 to \$236,863 at 30 June 2022 (2021: \$1,902,575) and had a working capital deficit of (\$864,313) (2021: \$(32,558) working capital deficit), as noted in Note 22.1.3 Going Concern on page 55. Please refer to the Operations Review above for additional business segment performance.

**5.6. Events Subsequent to Reporting Date**

On 16 July 2022 maturity of 62,500 convertible note issued matured and was redeemed.

On 25 August 2022, the Company announced the following:

- New funding of \$175,000.00 (USD) available immediately in a single tranche funded by an investor group including key Scout management personnel and directors of the Company.

On 7 September 2022, the Company announced the following:

- Completion of a \$930,000.00 placement to professional and sophisticated investors of 31.0m new shares at \$0.03/share, the maximum under LR7.1 and 7.1a capacity.
- Subject to shareholder approval, one free attaching option will be issued for every two shares issued under the Placement. Each option will have a \$0.07 exercise price and an expiry date of 16 July 2024.



- Non-renounceable rights issue on a 1-for-4 basis on the expanded capital base at the same terms as the Placement to raise up to a further \$1.38m. The closing date of the rights issue is 6 October 2022.

There are no other significant after balance date events that are not covered in this Directors' Report or within the financial statements as disclosed in Note 13 Events subsequent to reporting date on page 46.

#### 5.7. Future Developments, Prospects and Business Strategies

Likely developments in the operations of the Group have been disclosed in the Operating and Financial Review section of the Directors' Report.

Other likely developments, future prospects and business strategies of the operations of the Group and the expected results of those operations, not otherwise disclosed in this report, have not been included in this report as the Directors believe that the inclusion of such information would be likely to result in unreasonable prejudice to the Group.

    - (C) the Executive commits or becomes guilty of any gross misconduct; or
    - (D) refuses or neglects to comply with any lawful reasonable direction or order given to the Executive by Scout which the Executive, after receipt of prior notice, has failed to rectify to the reasonable satisfaction of Scout within 21 business days of receipt of that notice;

**1.3 Accounting policy****1.3.1 Revenue from contracts with customers**

Revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Company expects to receive in exchange for those goods or services.

Revenue is recognised by applying a five-step process outlined in AASB 15 which is as follows:

Step 1: Identify the contract with a customer;

Step 2: Identify the performance obligations in the contract and determine at what point they are satisfied;

Step 3: Determine the transaction price;

Step 4: Allocate the transaction price to the performance obligations; and

Step 5: Recognise the revenue as the performance obligations are satisfied.

Revenue is recognised when or as a performance obligation in the contract with customer is satisfied, i.e. when the control of the goods or services underlying the particular performance obligation is transferred to the customer. A performance obligation is a promise to transfer a distinct goods or service (or a series of distinct goods or services that are substantially the same and that have the same pattern of transfer) to the customer that is explicitly stated in the contract and implied in the Group's customary business practices.

Revenue is measured at the amount of consideration to which the Group expects to be entitled in exchange for transferring the promised goods or services to the customers, excluding amounts collected on behalf of third parties such as sales taxes or services taxes. If the amount of consideration varies due to discounts, rebates, refunds, credits, incentives, penalties or other similar items, the Group estimates the amount of consideration to which it will be entitled based on the expected value or the most likely outcome. If the contract with customer contains more than one performance obligation, the amount of consideration is allocated to each performance obligation based on the relative stand-alone selling prices of the goods or services promised in the contract. Revenue is recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur when the uncertainty associated with the variable consideration is subsequently resolved.

The control of the promised goods or services may be transferred over time or at a point in time. The control over the goods or services is transferred over time and revenue is recognised over time if:

- i. the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- ii. the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
- iii. the Group's performance does not create an asset with an alternative use and the Group has an enforceable right to payment for performance completed to date.

Revenue for performance obligation that is not satisfied over time is recognised at the point in time at which the customer obtains control of the promised goods or services.

**1.3.2 Revenue from sale of goods and development fees and licensing fees**

The Group recognises revenue when it satisfies a performance obligation by transferring a promised good or service to a customer. An asset is transferred when the customer obtains control of that asset. Revenue is recognised when the goods are shipped to the customer.

**1.3.3 Revenue from rendering of services**

Revenue from the monitoring services (subscriptions) is recognised over time, as the customer simultaneously receives and consumes the services performed by the Group (i.e. monitoring of the alarm system by Scout Security).

Liabilities for employee benefits for wages, salaries and annual leave that are expected to be settled within 12 months of the reporting date represent present obligations resulting from employees' services provided to the reporting date and are calculated at undiscounted amounts based on remuneration wage and salary rates that the Group expects to pay at the reporting date including related on-costs, such as workers compensation insurance and payroll tax.

Non-accumulating non-monetary benefits, such as medical care, housing, cars and free or subsidised goods and services, are expensed based on the net marginal cost to the Group as the benefits are taken by the employees.

**2. 1.2. Other long-term benefits**

The Group's obligation in respect of long-term employee benefits other than defined benefit plans, such as long service leave, is the amount of future benefit that employees have earned in return for their service in the current and prior periods plus related on-costs; that benefit is discounted to determine its present value, and the fair value of any related assets is deducted. The discount rate is the Reserve Bank of Australia's cash rate at the report date that have maturity dates approximating the terms of the Company's obligations. When applicable, the Group recognises a liability and expense for termination benefits at the earlier of: (a) the date when the Group can no longer withdraw the offer for termination benefits; and (b) when the Group recognises costs for restructuring pursuant to AASB 137 *Provisions, Contingent Liabilities and Contingent Assets* and the costs include termination benefits. In either case, unless the number of employees affected is known, the obligation for termination benefits is measured on the basis of the number of employees expected to be affected. Termination benefits that are expected to be settled wholly before 12 months after the annual reporting period in which the benefits are recognised are measured at the (undiscounted) amounts expected to be paid. All other termination benefits are accounted for on the same basis as other long-term employee benefits.

**2. 1.5. Equity-settled compensation**

The fair value of options granted is recognised as an employee expense with a corresponding increase in equity. The fair value is measured at grant date and spread over the period during which the employees become unconditionally entitled to the options. The fair value of the options granted is measured using the Black-Scholes pricing model, considering the terms and conditions upon which the options were granted. The amount recognised is adjusted to reflect the actual number of share options that vest except where forfeiture is only due to market conditions not being met.

Finance income comprises interest income on funds invested (including available-for-sale financial assets), gains on the disposal of available-for-sale financial assets and changes in the fair value of financial assets at fair value through profit or loss. Interest revenue is recognised on a time proportionate basis that considers the effective yield on the financial asset.

Financial expenses comprise interest expense on borrowings calculated using the effective interest method, unwinding of discounts on provisions, changes in the fair value of financial assets at fair value through profit or loss and impairment losses recognised on financial assets. All borrowing costs are recognised in profit or loss using the effective interest method.

Borrowing costs directly attributable to the acquisition, construction or production of assets that necessarily take a substantial period of time to prepare for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. All other borrowing costs are recognised in income in the period in which they are incurred.

Foreign currency gains and losses are reported on a net basis.

It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted by the balance date, in each jurisdiction.

Deferred income tax is provided on all temporary differences at the balance date between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred income tax liabilities are recognised for all taxable temporary differences except:

- when the deferred income tax liability arises from the initial recognition of goodwill or of an asset or liability in a transaction that is not a business combination and that, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; or
- when the taxable temporary difference is associated with investments in subsidiaries, associates or interests in joint ventures, and the timing of the reversal of the temporary difference can be controlled and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred income tax assets are recognised for all deductible temporary differences, carry-forward of unused tax assets and unused tax losses, to the extent that it is probable that taxable profit will be available against which the deductible temporary differences and the carry-forward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred income tax asset relating to the deductible temporary difference arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; or
- when the deductible temporary difference is associated with investments in subsidiaries, associates or interests in joint ventures, in which case a deferred tax asset is only recognised to the extent that it is probable that the temporary difference will reverse in the foreseeable future and taxable profit will be available against which the temporary difference can be utilised.

The carrying amount of deferred income tax assets is reviewed at each balance date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred income tax asset to be utilised.

Unrecognised deferred income tax assets are reassessed at each balance date and are recognised to the extent that it has become probable that future taxable profit will allow the deferred tax asset to be recovered. Deferred income tax assets and liabilities are measured at the tax rates that are expected to apply to the year when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the balance date.

Income taxes relating to items recognised directly in equity are recognised in equity and not in profit or loss. Deferred tax assets and deferred tax liabilities are offset only if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred tax assets and liabilities relate to the same taxable entity and the same taxation authority.

Scout Security Limited recognises its own current and deferred tax amounts and those current tax liabilities, current tax assets and deferred tax assets arising from unused tax credits and unused tax losses which it has assumed from its controlled entities within the tax consolidated group.

5.5.2 On 27 May 2022, the Company entered into an agreement to sell their US Government owed Employee Retention Credit ("ERC") to a group comprising off CEO Ryan McCall, Co-Founder Dan Roberts, and other parties. The Company will receive US\$248,219.02 in return of the sale of the rights of the ERC. The key features of the sale are summarized below:

Movements in the carrying amount are taken through OCI, except for the recognition of impairment gains or losses, interest income and foreign exchange gains and losses which are recognised in profit or loss. When the financial asset is derecognised, the cumulative gain or loss previously recognised in OCI is reclassified from equity to profit or loss and recognised in other gains/(losses). Interest income from these financial assets is included in finance income using the effective interest rate method. Foreign exchange gains and losses are presented in other gains/(losses) and impairment expenses are presented as separate line item in the statement of profit or loss.
- **FVPL:** Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVPL. A gain or loss on a debt investment that is subsequently measured at FVPL is recognised in profit or loss and presented net within other gains/(losses) in the period in which it arises.

Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the units and then to reduce the carrying amount of the other assets in the unit on a pro rata basis.

The recoverable amount of an asset or cash-generating unit is the greater of its fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. For an asset that does not generate largely independent cash inflows, the recoverable amount is determined for the cash-generating unit to which the asset belongs.

**8.2. Specific Financial Risk Exposures and Management**

The main risk the Group is exposed to through its financial instruments are credit risk, liquidity risk and market risk consisting of interest rate, foreign currency risk and equity price risk.

The Board of directors has overall responsibility for the establishment and oversight of the risk management framework. The Board adopts practices designed to identify significant areas of business risk and to effectively manage those risks in accordance with the Group's risk profile. This includes assessing, monitoring and managing risks for the Group and setting appropriate risk limits and controls. The Group is not of a size nor is its affairs of such complexity to justify the establishment of a formal system for risk management and associated controls. Instead, the Board approves all expenditure, is intimately acquainted with all operations and discuss all relevant issues at the Board meetings. The operational and other compliance risk management have also been assessed and found to be operating efficiently and effectively.

**Note 8 Financial risk management (cont.)****8.2.1. Credit risk**

Exposure to credit risk relating to financial assets arises from the potential non-performance by counterparties of contract obligations that could lead to a financial loss to the Group.

Credit risk refers to the risk that counterparty will default on its contractual obligations resulting in financial loss to the Group. The Group has adopted a policy of only dealing with creditworthy counterparties and obtaining sufficient collateral where appropriate, as a means of mitigating the risk of financial loss from defaults. The Group only transacts with entities that are rated the equivalent of investment grade and above. This information is supplied by independent rating agencies where available and, if not available, the Group uses publicly available financial information and its own trading record to rate its major customers. The Group's exposure and the credit ratings of its counterparties are continuously monitored and the aggregate value of transactions concluded is spread amongst approved counterparties. Credit exposure is controlled by counterparty limits that are reviewed and approved by the risk management committee annually.

The Group establishes an allowance for impairment that represents its estimate of incurred losses in respect of trade and other receivables.

■ *Credit risk exposures*

The maximum exposure to credit risk is that to its alliance partners and that is limited to the carrying amount, net of any provisions for impairment of those assets, as disclosed in the statement of financial position and notes to the financial statements.

Credit risk related to balances with banks and other financial institutions is managed by the Group in accordance with approved Board policy. Such policy requires that surplus funds are only invested with financial institutions residing in Australia, wherever possible.

**8.2.2. Liquidity risk**

Liquidity risk is the risk that the Group will not be able to meet its financial obligations as they fall due. The Group's approach to managing liquidity is to ensure, as far as possible, that it will always have sufficient liquidity to meet its liabilities when due, under both normal and stressed conditions, without incurring unacceptable losses or risking damage to the Group's reputation.

Ultimate responsibility for liquidity risk management rests with the Board, who have built an appropriate liquidity risk management framework for the management of the Group's short, medium and long-term funding and liquidity management requirements. The Group manages liquidity risk by maintaining adequate reserves, banking facilities and reserve borrowing facilities by continuously monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities. The Group's ability to raise equity funding in the market is paramount in this regard.

Typically, the Group ensures that it has sufficient cash to meet expected operational expenses for a period of 60 days, including the servicing of financial obligations; this excludes the potential impact of extreme circumstances that cannot reasonably be predicted, such as natural disasters.

The financial liabilities of the Group include trade and other payables as disclosed in the statement of financial position. All trade and other payables are non-interest bearing and due within 30 days of the reporting date.

It is not expected that the cash flows included in the maturity analysis could occur significantly earlier or at significantly different amounts.

### 8.2.3. Market risk

Market risk is the risk that changes in market prices, such as foreign exchange rates, interest rates and equity prices will affect the Group's income or the value of its holdings of financial instruments. The objective of market risk management is to manage and control market risk exposures within acceptable parameters, while optimising the return.

The Group's activities minimally expose it to the financial risks of changes in foreign currency exchange rates, commodity prices and exchange rates. The Group does not enter into derivative financial instruments including foreign exchange forward contracts to hedge against financial risk. There has been no change to the Group's exposure to market risks or the manner in which it manages and measures the risk from the previous period.

#### 8.2.3.1. Interest rate risk

The company and the Group are exposed to interest rate risk as entities in the Group borrow funds at both fixed and floating interest rates. The risk is managed by the Group by maintaining an appropriate mix between fixed and floating rate borrowings.

**8.2.3.2. Foreign exchange risk**

Exposure to foreign exchange risk may result in the fair value or future cash flows of a financial instrument fluctuating due to movement in foreign exchange rates of currencies in which the Group holds financial instruments which are other than the AUD functional currency of the Group. As a result of significant operations in the United States, the Group's Consolidated Statement of Financial Position can be affected significantly by movements in the US Dollar to Australian dollar exchange rates.

**8.2.3.3. Price risk**

Price risk relates to the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. The Group does not presently hold material amounts subject to price risk. As such the Board considers price risk as a low risk to the Group.

**8.2.4. Sensitivity Analyses**

The excess of the consideration transferred the amount of any non-controlling interest in the acquiree and the acquisition-date fair value of any previous equity interest in the acquiree over the fair value of the Group's share of the net identifiable assets acquired is recorded as goodwill.

If those amounts are less than the fair value of the net identifiable assets of the subsidiary acquired and the measurement of all amounts has been reviewed, the difference is recognised directly in profit or loss as a bargain purchase.

The consideration transferred does not include amounts related to settlement of pre-existing relationships. Such amounts are generally recognised in profit or loss.

Costs related to the acquisition, other than those associated with the issue of debt or equity securities, that the Group incurs in connection with a business combination are expensed as incurred.

Where settlement of any part of cash consideration is deferred, the amounts payable in the future are discounted to their present value as at the date of exchange. The discount rate used is the entity's incremental borrowing rate, being the rate at which a similar borrowing could be obtained from an independent financier under comparable terms and conditions.

Any contingent consideration payable is recognised at fair value at the acquisition date. If the contingent consideration is classified as equity, it is not remeasured and settlement is accounted for within equity. Otherwise, subsequent changes to the fair value of the contingent consideration are recognised in profit or loss.

Subsequent to initial recognition, non-controlling interests are attributed their share of profit or loss and each component of other comprehensive income. Non-controlling interests are shown separately within the equity section of the statement of financial position and statement of comprehensive income.

The grant by the company of options over its equity instruments to the employees of subsidiary undertakings in the group is treated as a capital contribution to that subsidiary undertaking. The fair value of employee services received, measured by reference to the grant date fair value, is recognised over the vesting period as an increase to investment in subsidiary undertakings, with a corresponding credit to equity.

Losses applicable to the non-controlling interests in a subsidiary are allocated to the non-controlling interests even if doing so causes the non-controlling interests to have a deficit balance.

**11.1.3. Loss of control**

**Note 22. Statement of significant accounting policies**

This note provides a list of the significant accounting policies adopted in the preparation of these consolidated financial statements to the extent they have not already been disclosed in the other notes above. These policies have been consistently applied to all the years presented, unless otherwise stated.

**22.1. Basis of preparation****22.1.1. Reporting Entity**

Scout Security Limited (Scout or the Company) is a listed public company limited by shares, domiciled and incorporated in Australia. These are the consolidated financial statements and notes of Scout and controlled entities (collectively the Group). The financial statements comprise the consolidated financial statements of the Group. For the purposes of preparing the consolidated financial statements, the Company is a for-profit entity. The Group is a for-profit entity and is primarily involved in the design, manufacture and sales of security systems.

The separate financial statements of Scout, as the parent entity, have not been presented with this financial report as permitted by the Corporations Act 2001 (Cth).

**22.1.2. Basis of accounting**

These financial statements are general purpose financial statements which have been prepared in accordance with Australian Accounting Standards and Interpretations of the Australian Accounting Standards Board (AAS Board) and International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board (IASB), and the Corporations Act 2001 (Cth).

Australian Accounting Standards (AASBs) set out accounting policies that the AAS Board has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions to which they apply. Compliance with AASBs ensures that the financial statements and notes also comply with IFRS as issued by the IASB.

The financial statements were authorised for issue on 28 September 2022 by the directors of the Company.

**22.1.3. Going Concern**

The financial report has been prepared on a going concern basis, which contemplates the continuity of normal business activity and the realisation of assets and the settlement of liabilities in the ordinary course of business.

The Group incurred a loss for the year of \$3,288,924 (2021: \$3,943,796) and a net cash out-flow from operating activities of \$3,755,952 (2021: \$2,153,484 out-flow). As at 30 June 2022, the Company a working capital deficit of \$864,313 (2021: \$32,558 working capital deficit), as disclosed in Note 9 of the Capital Management note.

The ability of the Group to continue as a going concern is dependent on executing its near and medium term plans for expansion of its product portfolio; or on securing additional debt and/or equity funding in the event that sufficient revenue is not generated in the normal course of business.

These conditions indicate the existence of a material uncertainty that may cast a significant doubt about the Group's ability to continue as a going concern and, therefore, that it may be unable to realise its assets and discharge its liabilities in the normal course of business.

The Directors have prepared a cash flow forecast, which indicates that the Group will have sufficient cash flows to meet all commitments and working capital requirements for the 12 month period from the date of signing this financial report. The Directors believe it is appropriate to prepare these accounts on a going concern basis because:

- On 25 August 2022: New Funding of \$175,000 USD available immediately in a single tranche funded by an investor group including key Scout management personnel and directors of the Company
- On 7 September 2022: Completion of a \$930,000 placement to professional and sophisticated investors of 31.0m new shares at \$0.03/share, the maximum under LR7.1 and 7.1a capacity
- Expected on 6 October 2022 closing date, Non-renounceable rights issue on a 1-for-4 basis on the expanded capital base at the same terms as the Placement to raise up to a further \$1.38m.
- The month on month growth of existing white label customers, along with the addition of new ones, will increase incoming cash payments on an ongoing basis, thus bolstering the financial stability. New white label customer includes 250k USD of development revenue projected before the close of calendar year 2022.
- Management have prepared a cashflow forecast for the next 12 months that indicates the operating cash inflows will be sufficient to meet expenses and other financial obligations as and when they are due;
- Managing cash flows in line with available funds; and
- The group is pursuing options for non-dilutive funding via a long term working capital facility

The directors plan to continue the Group's operations on the basis disclosed above and believe that there will be sufficient funds for the Group to meet its obligations and liabilities for at least 12 months from the date of this report. In the event that the Group is unable to generate sufficient revenue in the normal course of business or secure additional funds through new share issues or borrowings, the Group may need to reduce costs or negotiate extended terms with key creditors in order to meet working capital requirements.

The financial report does not include any adjustments relating to the recoverability and classification of recorded asset amounts or liabilities that might be necessary should the entity not continue as a going concern and meet its debts as and when they become due and payable.

**22.1.4. Comparative figures**

Where required by AASBs comparative figures have been adjusted to conform to changes in presentation for the current financial year.

Where the Group retrospectively applies an accounting policy, makes a retrospective restatement or reclassifies items in its financial statements, an additional (third) statement of financial position as at the beginning of the preceding period in addition to the minimum comparative financial statements is presented.

The amendments listed above did not have any impact on the amounts recognised in prior periods and are not expected to significantly affect the current or future periods.

**22.2. Value added taxes**

Value-added tax (**VAT**) is the generic term for the broad-based consumption taxes that the Group is exposed to such as: Australia (**Goods and Services Tax** or **GST**) and in the USA (**Sales Tax**), hereafter collectively referred to as GST.

Revenues, expenses, and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

The net amount of GST recoverable from, or payable to, the Australian Taxation Office (or jurisdictional equivalent) is included as a current asset or liability in the balance sheet.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the taxation authority.

**22.3. Foreign currency transactions and balances****22.3.1. Functional and presentation currency**

The functional currency of each of the Group's entities is measured using the currency of the primary economic environment in which that entity operates. The consolidated financial statements are presented in Australian dollars which is the legal parent entity's functional and presentation currency. The functional currency of Scout Security Inc. is the United States Dollar.

Foreign currency transactions are translated into functional currency using the exchange rates prevailing at the date of the transaction. Foreign currency monetary items are translated at the year-end exchange rate. Non-monetary items measured at historical cost continue to be carried at the exchange rate at the date of the transaction. Non-monetary items measured at fair value are reported at the exchange rate at the date when fair values were determined.

Exchange differences arising on the translation of monetary items are recognised in the profit or loss except where deferred in equity as a qualifying cash flow or net investment hedge.

Exchange differences arising on the translation of non-monetary items are recognised directly in other comprehensive income to the extent that the gain or loss is directly recognised in other comprehensive income, otherwise the exchange difference is recognised in the profit or loss.

**22.3.3. Group companies and foreign operations**

The financial results and position of foreign operations whose functional currency is different from the Group's presentation currency are translated as follows:

- assets and liabilities are translated at year-end exchange rates prevailing at that reporting date;
- income and expenses are translated at average exchange rates for the period; and
- retained earnings are translated at the exchange rates prevailing at the date of the transaction.

Exchange differences arising on translation of foreign operations are transferred directly to the Group's foreign currency translation reserve in the statement of financial position. These differences are recognised in the profit or loss in the period in which the operation is disposed.

**22.4. Use of estimates and judgments**

The preparation of consolidated financial statements requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses. These estimates and associated assumptions are based on historical experience and various factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

Judgements made by management in the application of AASBs that have significant effect on the consolidated financial statements and estimates with a significant risk of material adjustment in the next year are discussed in Note 22.4.1.

The Group measures some of its assets and liabilities at fair value on either a recurring or non-recurring basis, depending on the requirements of the applicable AASB.

Fair value is the price the Group would receive to sell an asset or would have to pay to transfer a liability in an orderly unforced transaction between independent, knowledgeable and willing market participants at the measurement date.

As fair value is a market-based measure, the closest equivalent observable market pricing information is used to determine fair value. Adjustments to market values may be made having regard to the characteristics of the specific asset or liability. The fair values of assets and liabilities that are not traded in an active market are determined using one or more valuation techniques. These valuation techniques maximise, to the extent possible, the use of observable market data.

To the extent possible, market information is extracted from either the principal market for the asset or liability (i.e. the market with the greatest volume and level of activity for the asset or liability) or, in the absence of such a market, the most advantageous market available to the entity at the end of the reporting period (i.e. the market that maximises the receipts from the sale of the asset or minimises the payments made to transfer the liability, after taking into account transaction costs and transport costs).

For non-financial assets, the fair value measurement also considers a market participant's ability to use the asset in its highest and best use or to sell it to another market participant that would use the asset in its highest and best use.

The fair value of liabilities and the entity's own equity instruments (excluding those related to share-based payment arrangements) may be valued, where there is no observable market price in relation to the transfer of such financial instruments, by reference to observable market information where such instruments are held as assets. Where this information is not available, other valuation techniques are adopted and, where significant, are detailed in the respective note to the financial statements.

**22.5.2. Fair value hierarchy**

AASB 13 Fair Value Measurement requires the disclosure of fair value information by level of the fair value hierarchy, which categorises fair value measurements into one of three possible levels based on the lowest level that an input that is significant to the measurement can be categorised into as follows:

The fair values of assets and liabilities that are not traded in an active market are determined using one or more valuation techniques. These valuation techniques maximise, to the extent possible, the use of observable market data. If all significant inputs required to measure fair value are observable, the asset or liability is included in Level 2. If one or more significant inputs are not based on observable market data, the asset or liability is included in Level 3.

The Group would change the categorisation within the fair value hierarchy only in the following circumstances:

- if a market that was previously considered active (Level 1) became inactive (Level 2 or Level 3) or vice versa; or
- if significant inputs that were previously unobservable (Level 3) became observable (Level 2) or vice versa.

When a change in the categorisation occurs, the Group recognises transfers between levels of the fair value hierarchy (i.e. transfers into and out of each level of the fair value hierarchy) on the date the event or change in circumstances occurred.

**22.5.3. Valuation techniques**

The Group selects a valuation technique that is appropriate in the circumstances and for which sufficient data is available to measure fair value. The availability of sufficient and relevant data primarily depends on the specific characteristics of the asset or liability being measured. The valuation techniques selected by the Group are consistent with one or more of the following valuation approaches:

- Market approach: valuation techniques that use prices and other relevant information generated by market transactions for identical or similar assets or liabilities.
- Income approach: valuation techniques that convert estimated future cash flows or income and expenses into a single discounted present value.
- Cost approach: valuation techniques that reflect the current replacement cost of an asset at its current service capacity.

Each valuation technique requires inputs that reflect the assumptions that buyers and sellers would use when pricing the asset or liability, including assumptions about risks. When selecting a valuation technique, the Group gives priority to those techniques that maximise the use of observable inputs and minimise the use of unobservable inputs. Inputs that are developed using market data (such as publicly available information on actual transactions) and reflect the assumptions that buyers and sellers would generally use when pricing the asset or liability are considered observable, whereas inputs for which market data is not available and therefore are developed using the best information available about such assumptions are considered unobservable.

**22.6. New Accounting Standards and Interpretations not yet mandatory or early adopted**
