

**ASX ANNOUNCEMENT****22 May 2024****LISTED OPTIONS EXPIRY – Correction of official quotation cessation date**

Stavely Minerals Limited (ASX:SVY) (the “Company”) advises holders of the Company’s 24,277,766 quoted options (ASX: SVYOA) exercisable at \$0.15 each will expire effective 5.00pm (AWST) on 30 June 2024 (“Expiry Date”).

Paragraph 5.3 of Appendix 6A of the ASX Listing Rules provides that a listed entity is not required to send a notice to holders of quoted options that are about to expire where the options are substantially out of the money (that is, where the closing market price for the underlying securities on the trading day which is 20 business days before the expiry date is less than 50% of the option exercise price and the highest market price at which the underlying securities have traded on the ASX in the 6 months preceding that trading day is less than 75% of the option exercise price). The Company advises that option expiry notices will not be sent to the holders of the Options as the Options are substantially out of the money.

In accordance with paragraph 5.2 of Appendix 6A of the ASX Listing Rules, the Company provides the following information:

- The number of options to which this notice applies 24,277,766;
- Each option, when exercised, entitles the holder to receive one fully paid ordinary share in the Company. If all options were exercised, 24,277,766 fully paid ordinary shares would be issued;
- The exercise price of each option is \$0.15;
- The due date for payment of the exercise price is 5.00pm (AWST) on 30 June 2024;
- If payment is not received before the Expiry Date, the options will expire unexercised and all rights will cease;
- Official quotation of the options ceases 24 June 2024, being four business days before the Expiry Date;
- The closing market price of fully paid ordinary shares in the Company on 20 May 2024 (being the last trading day prior to the date of this notice) was \$0.049;
- During the three months immediately preceding the date of this announcement:
  - the highest market price of fully paid ordinary shares in the Company was \$0.052 on 20 May 2024; and
  - the lowest market price of fully paid ordinary shares in the Company was \$0.025 on 13 May 2024; and
- No underwriting agreement exists in respect of these options.
