## NOTICE TO ELIGIBLE SHAREHOLDERS OF PRO-RATA NON-RENOUNCEABLE ENTITLEMENT OFFER TO RAISE UP TO APPROXIMATELY \$0.366 MILLION

On behalf of your Directors, I am pleased to invite you to participate in this non-renounceable pro-rata 1 for 8 entitlement offer at an issue price of \$0.02 per share (**New Shares**) to raise up to approximately \$0.366 million (before costs) (**Entitlement Offer**).

Under the Entitlement Offer, Eligible Shareholders are entitled to subscribe for 1 New Share for every 8 existing Shares in the Company held on the Record Date, being 5.00pm (AWST) on 6 June 2025 (**Record Date**). Participants in the Entitlement Offer will also be issued 1 free attaching unquoted Option exercisable at \$0.04 and expiring 2 years from their issue date for every 2 New Shares subscribed for and issued under the Entitlement Offer (**New Options**). Further details in respect of how Eligible Shareholders can participate in the Entitlement Offer are set out in Sections 2.2 and 2.3 of the Prospectus.

Eligible Shareholders may also apply (in excess of their Entitlement) for New Shares and New Options not subscribed for pursuant to the Entitlement Offer at the same issue price as the Entitlement Offer (subject to the allocation policy set out in Section 1.2) (**Top-Up Offer**). Further details in respect of how Shareholders can participate in the Top-Up Offer are set out in Section 2.4 of the Prospectus.
