### Background

I refer to:

- the appointment of Kathryn Evans, Ben Campbell and I, Vaughan Strawbridge, as Joint and Several Administrators ("Administrators") of the Companies on 26 July 2024 pursuant to section 436A of the *Corporations Act 2001* (Cth) ("the Act");
- the Deed of Company Arrangement ("DOCA") proposed by OL Master Limited ("OCP") and executed on 19 December 2024, pursuant to which, amongst other things, the Administrators were appointed as Deed Administrators of the Companies;
- the circular dated 24 March 2025 which advised that his Honour Justice Black of the Supreme Court of New South Wales has ordered, amongst other things, that the Deed Administrators be granted leave to transfer all of the shares in Aeon Metals from the current shareholders to OCP or its nominee ("Section 444GA Order").

### Effectuation of the DOCA

The Deed Administrators advise that all shares in Aeon Metals have now been transferred to OCP or its nominee in accordance with the Section 444GA Order and the DOCA.

The Deed Administrators also advise that completion and effectuation of the DOCA has occurred today, 23 April 2025.

### Officers of the Companies

Mr Ivan Wong ceased his role as Director of Aeon Metals and Aeon Walford Creek effective 7 April 2025.

As directed by OCP, the new officers have been appointed to the Companies effective today, 23 April 2025 as noted below:


Following effectuation of the DOCA, control of the Companies reverted to their directors.
