NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

As announced on 14 April 2025, Grand Gulf Energy Ltd (ASX:GGE) (**Grand Gulf** or the **Company**) received firm commitments from sophisticated and professional investors to undertake a placement to raise \$700,000 (before costs) through the issue of 350,000,000 fully paid ordinary shares in the capital of the Company (**Shares**) (**Placement Shares**) at an issue price of \$0.002 per Placement Share. The Company has today completed the issue of 350,000,000 Placement Shares pursuant to the Company's placement capacity under Listing Rules 7.1 and 7.1A.
