**UBS DIVIDEND BUILDERS: DISTRIBUTION ANNOUNCEMENT**

*The prior announcement dated 08 March 2017 has been revised and reissued following confirmation by BHP Billiton Limited of the foreign exchange rate applied to convert the USD distribution into Australian dollars*

Holders should be aware that BHP Billiton Limited may amend the amount of the Distribution payable, including for changes in foreign exchange rates (or revoke payment of the Distribution), prior to the Distribution payment date and Holders are entitled only to the Distribution actually paid by BHP Billiton Limited.

The Distribution amount will be paid to Holders as soon as reasonably practicable after receipt of the Distribution in cleared funds by UBS Nominees Pty Ltd, as Security Trustee, from BHP Billiton Limited (payment to Holders is expected to be made within 5 Business Days of the Security Trustee receiving the Distribution). The Security Trustee is expected to receive such funds on 28 Mar 2017, the Distribution payment date.
