New Issue of Shares - Notice Under Section 708A(5)(e) of the Corporations Act

Today, Po Valley Energy Limited (**Company**) issued **10,909,091** fully paid ordinary shares in the capital of the Company (ASX code: PVE) at an issue price of \$0.055 (5.5 cents) per share.
