

Chubb Life Assurance begins engagement with Onify

Onify will bill Chubb Life Assurance on a time and materials basis, with an expected minimum initial engagement totalling AUD 90,000 over the next six months. The agreement is otherwise on terms considered commercial for an agreement of this nature.

Onify expects to build on this initial engagement and significantly expand its activities with Chubb Life Assurance, pending the successful integration of the Onify team within their corporate activities in Thailand.
